| 1.9 | Dismissed for using offensive, insulting, or abusive language and/or gestures directed at anyone other than the game official(s) | 1-game suspension | 3-game suspension | |
| 1.10 | Dismissed for using offensive, insulting, or abusive language and/or gestures directed at the game official(s) | 3-game suspension | 6-game suspension | 1-session suspension |
| 1.11 | Persisted in using offensive, insulting, or abusive language and/or gestures directed at a game official(s) after having been dismissed for such action that is directly in the area of the soccer field | 6-game suspension | 12-game suspension | 1-year suspension |
| 1.12 | Dismissed for denying an opponent a goal or an obvious goal-scoring opportunity by deliberately handling the ball | 1-game suspension | 2-game suspension | |
| 1.14 | Dismissed for denying an opponent a goal or an obvious goal-scoring opportunity by committing an offence punishable by a free kick or penalty kick | 2-game suspension | 4-game suspension | |
| 1.15 | Dismissed for a serious foul play or for deliberate physical contact (ie., pushing, pulling, etc.) | 2-game suspension | 4-game suspension | |
| 1.16 | Dismissed for a serious foul play where there was an attempt to injure or a complete disregard for the safety of an opponent | 6-game suspension | 12-game suspension | |
| 1.17 | Dismissed for spitting at an opponent or any other person other than the game official(s) | 2-game suspension | 4-game suspension | |

| 1.20 | Knowingly played as an ineligible player | 4-game suspension | 8-game suspension | 1-year suspension |
| 1.21 | Game official assault for spitting, deliberate physical contact (ie., pushing, pulling, etc.) or attempted physical contact or physical threats | 1-year suspension | Lifetime suspension | |
| 1.22 | Game official assault for striking, kicking, or any form of violent conduct or attempted violent conduct | Lifetime suspension | | |
| 1.23 | Delayed match by neglecting to immediately leave the playing area after having been dismissed; or returned to the playing area after having been previously dismissed | 2-game suspension | 4-game suspension | |
| 1.24 | Participated in a game from which he/she was suspended | 6-game suspension | 1-year suspension | Lifetime suspension |
| 1.25 | Registered under a false name | 6-game suspension | 1-year suspension | Lifetime suspension |
